Rosa Luisa

Hi everybody, I am Rosa Luisa Rossi from Switzerland and I am your co-chair together with Marya Spring Cordes since October 2019. I am an ATI member since 1995.

As I am the liaison person from the ATI Board to the Ethic Advisory Committee I am not directly involved in the work behind the scene.

I participate in the EAC meetings and report from the Board to the Committee and back to the Board. Peter, please continue.

Peter

I'm Peter Nobes. I teach the Alexander work, and train teachers, in central London UK. I've been a teaching member of ATI since about 1998, and I've been a sponsor since 2005. My book on the Alexander Technique was published in 2018, and I'm currently writing another.

I brought expertise to this committee: when I was a member of STAT someone made a complaint against me, and a few years later I made a complaint about someone. So I have seen the process from both sides. I'm going to hand you over to Rachel.

Rachel

I'm Rachel Prabhakar. I live in Boston, in the U.S. I've been a member of ATI since 2014, and I've been serving on the EAC since December. It is a pleasure to work with the wonderful people on this committee and to support the mission of ATI.

What we have been working on...

Mike

So now that we've introduced ourselves we'd like to tell you what we've been working on. Our current formal complaints process is written before the digital era. We are exploring ways to use technology to streamline the communication process and document storage requirements without comprising security, confidentiality or reliability.

Maria

The Ethics Advisory Committee has been working to address the issues raised at the plenary session at the last AGM in Ireland. These include constructing a recommendation to the board for an Ombudsman and debating whether or not to allow filing anonymous complaints.

Rachel

At last year's AGM, there were some suggestions that we should adopt procedures allowing people to file an ethics complaint anonymously. We certainly understand and respect the concerns that led to these suggestions. One of the EAC's tasks this year was to research this topic and come up with a recommendation. We have looked at best practices and policies of other organizations, and discussed what would best meet the needs of ATI. In the end, we decided not to recommend an anonymous complaints policy, because we feel that we would not be able to investigate a truly anonymous complaint (we should mention that the committee works with the strictest confidentiality). If an ethics complaint allegation is made, the EAC is charged with investigating the complaint in a way that is fair, supportive, and that protects the public, trainees, and teachers. If we don't know who is making the complaint, there is no way to conduct a fair investigation.

While we are not recommending adopting an anonymous complaints policy, we would like to bring a recommendation to our membership about ways that we could modify the current complaints policy to make it more supportive, in the hopes that would address some of the underlying concerns that led to the suggestions about anonymous complaints. Peter will give us more information on that.

Peter

We're planning a comfortable, supportive pre-process that people can go through. They can approach us and we can help support them and guide them through the process of deciding whether to escalate it into a formal complaint. We're intending to bring a proposal to you at the conference next year so that it can be voted on

Jamee

Thanks Peter. On the topic of the Ombudsman. Basically what it means is to be able to have a complaints and resolution process for the administration for the organization. Right now we address individuals. We are currently working on the skillset required for that position. Our task is to make a recommendation to the Board and we feel we can trust the Board to make a good decision rather than having to go to the membership for a vote.
